#### CALL TO ORDER

Mayor Ervin called the November 14, 2022 regular meeting of Florence City Council to order at 1:00 p.m.

#### INVOCATION

Mayor Ervin gave the invocation for the meeting. The pledge of allegiance to the American Flag followed the invocation.

#### APPROVAL OF MINUTES

Councilwoman Barnes made a motion to adopt the minutes of the October 10, 2022 regular meeting and Councilman Braddock seconded the motion. The minutes were unanimously adopted.

### APPEARANCES BEFORE COUNCIL



# **Mayor Teresa Myers Ervin**

Mayor Ervin presented a Proclamation to Councilwoman Moore acknowledging her profound impact to the community and notable contributions to the City of Florence. Mayor Ervin also presented a Key to the City to Councilwoman Moore for all that she has done, all she is doing, and all she will continue to do for the residents of Florence and for her efforts as founder of the SC Pecan Music and Food Festival. Mayor Ervin then presented Councilwoman Moore with a service award for her years of service on City Council representing District Two from August 1, 2016 to November 21, 2022.

Mayor Ervin also presented Councilman Schofield with a service award for his years of service on City Council representing District One from May 8, 2021 to November 21, 2022.

#### Ms. Clamentine Elmore, Executive Director - Housing Authority

Ms. Clamentine Elmore appeared before Council and presented Councilwoman Moore with an award of appreciation for her nine years of dedicated service on the Housing Authority Board of Commissioners from 1996 to 2005.

Ms. Elmore also provided an update on the Housing Authority and the Pine Street location. She said the Housing Authority aims to provide affordable housing and promote homeownership in the City. Ms. Elmore said a developer is with her today to discuss plans for the Pine Street location which will allow for more affordable housing opportunities for residents.

Pro tem Jebaily asked how many units are proposed. The developer responded approximately seventy units, configured of one, two and three bedrooms. Florence County caps at seventy units to qualify for the 9% program in South Carolina.

Councilman McCall inquired on the total investment amount for the project and the developer responded the costs for construction and development will be approximately \$17-18 million with the balance coming from tax credits and mortgage.

Councilwoman Moore asked if there will be rent to own opportunities and the developer said they have discussed this as an option. South Carolina does incentivize for homeownership with the tax credit program and they have been looking at this option for some of the Housing Authority's larger sites; however, this site will be all rental due to the site's size. Ms. Elmore clarified that more information on the rent to own and potential homeownership sites will be forthcoming.

Councilwoman Barnes made a motion to adopt Bill No. 2022-34 on second reading and Pro tem Jebaily seconded the motion.

Council voted unanimously (7-0) in favor of the motion. Bill No. 2022-34 was adopted on second reading.

Pro tem Jebaily made a motion to pass Bill No. 2022-35 on first reading and Councilman Braddock seconded the motion.

Councilman McCall made a motion to amend the motion to move Bill No. 2022-35 to Executive Session to receive legal advice and Councilwoman Moore seconded the motion. Council voted unanimously on the motion, as amended. Bill No. 2022-35 was moved to Executive Session for legal advice.

#### <u>Resolution No. 2022-32</u> A Resolution to proclaim Friday, December 2, 2022 as Arbor Day in the City of Florence.

Councilman McCall made a motion to adopt Resolution No. 2022-32 and Councilwoman Moore seconded the motion.

Council voted unanimously (7-0) in favor of the motion. Resolution No. 2022-32 was adopted.

#### Resolution No. 2022-33

A Resolution to recognize November as Acts of Kindness Month in the City of Florence.

Councilman McCall made a motion to adopt Resolution No. 2022-33 and Councilwoman Moore seconded the motion.

Resolution 2022-33 was read into record by Councilwoman Barnes.

Council voted unanimously (7-0) in favor of the motion. Resolution No. 2022-33 was adopted.

#### Resolution No. 2022-34

A Resolution to establish a multi-year budget to designate and authorize the use of E-911 funds for Fiscal Years beginning July 1, 2022 and ending June 30, 2029.

Mayor Ervin said staff has requested that this item be deferred. Without objection, this item was deferred.

#### Resolution No. 2022-35

A Resolution authorizing the execution of an Incentive Agreement with an economic development project; authorizing the execution of an Intergovernmental Agreement with Florence County regarding the acquisition of land pertaining to the economic development project; and other matters related thereto.

Mayor Ervin said this item is to be discussed in Executive Session. Without objection, this item will be discussed in Executive Session.



## **REPORTS TO COUNCIL**

#### **Appointments to Boards and Commissions**

Mr. Scotty Davis, Deputy City Manager, presented the packet of appointments to Boards and Commissions to Council.

#### Parks and Beautification Commission

Pro tem Jebaily made a motion to appoint Josiellia Williams. Without objection, Josiellia Williams was appointed to the Parks and Beautification Commission for a term to begin immediately and expire on June 30, 2027.

Councilwoman Barnes made a motion to appoint Itisa Harley-Williams. Without objection, Itisa Harley-Williams was appointed to the Parks and Beautification Commission for a term to begin immediately and expire on June 30, 2024.

#### **City-County Memorial Stadium Commission**

Councilman McCall deferred his nomination for the Commission.

#### Public Safety Citizen's Review Board

Mayor Ervin deferred her nomination for the Board.

#### **Appointment of Aesthetics Advisory Committee Chairperson**

Mr. Davis said the initial chairperson for this committee must be appointed by Council. The Committee met and has recommended Ms. Leigh King as chair of the committee.

Councilman McCall made a motion to appoint Leigh King as chair of the Aesthetics Advisory Committee and Councilwoman Barnes seconded the motion. Council voted unanimously (7-0) in favor of the motion.

#### Appropriation of Accommodations Tax funds for FY2022/23

Mr. Yokim reported this matter was referred to the Finance, Audit and Budget Committee for additional review at last month's Council meeting. The Committee met and reviewed the recommendations and voted to recommend these appropriations be approved

Councilwoman Moore made a motion to approve the appropriation of Accommodations Tax funds for FY2022/23 as recommended and Councilman McCall seconded the motion.

Council voted unanimously (7-0) in favor of the motion. The list of recommendations is attached and made part of these minutes.

#### COMMITTEE REPORTS

Business Development Committee, Chaired by Pro tem Jebaily



Pro tem Jebaily reported that Project Urban Square is underway with demolition by the city and the developer and preliminary streetscape work is being completed for Coit Street. The Nofal building project is moving forward and will include a downstairs retail/office and the upper two floors will be housing. The Lost Cajun is expected to open soon at 95% completion. The Committee received a review of the third penny projects and the story map for the projects will be available on the city website soon. Discussion was continued on stormwater projects as well as utility construction projects. There was recommendation from the Committee to decrease the 10-year time frame to complete the asset management study; however, due to various limitations the time frame to complete the study cannot be decreased. Pro tem Jebaily said discussion regarding the old hotel site and expansion of the east Florence corridor continued. The Committee made a recommendation to form an ad hoc committee that would specifically look at the east Florence corridor.

Councilman Schofield made a motion that Council approve the formation of the ad hoc East Florence Gateway Study Committee to operate under the Business Development Committee with Pro tem Jebaily serving as its chair and Councilman McCall serving as its co-chair, whose purpose will be to study the east Florence corridor and provide ideas and recommendations for the redevelopment of that corridor. Further, the Business Development Committee will make recommendations regarding the makeup of the ad hoc committee and the nomination of its members, to be appointed by City Council. Councilwoman Barnes seconded the motion.

Councilwoman Moore spoke in opposition of the formation of an ad hoc committee prior to the new Councilmembers beginning their term. She also said the east Florence community organization should have a say in the committee.

Councilman McCall asked the City Attorney, Jim Peterson, what the process will be for all the city's ad hoc committees once the new Councilmembers are on board. He questioned if appointments to the ad hoc committee are made today, will they need to be redone once the new Council members take office at next month's meeting. Mr. Peterson said his understanding is that appointments to the committee are not being made today, only establishing the committee. The new Councilmembers will be on board by the time recommendations are considered. Mr. Peterson clarified that as the Council composition changes, ad hoc committee membership would need to be addressed. Mayor Ervin said Pro tem Jebaily and Councilman McCall were named to be chair and co-chair in the motion, making them part of the membership of the ad hoc committee. She inquired if these appointments would need to be considered at the next meeting also. Mr. Peterson said if the motion passes, those two names will be on the list for appointment recommendation at the next meeting. To clarify, Mayor Ervin said, if the motion passes, these two names will be on the committee until the committees are vacated and appointments are made next month when the new members are on board and Mr. Peterson said that is correct.

Councilwoman Moore said Council-elect Smith will be the representative for District Two and he should automatically be the chair of the ad hoc committee. Further, Mr. Kermit Moore is the president of the East Florence Community Organization and he should automatically be a member of the committee as well. She reiterated that she strongly opposed the formation of the ad hoc committee at this time.

Councilman McCall said he wants to see the corridor enhanced and the city moving forward, but he does not want this to be complicated. Councilman McCall then made a motion to amend the motion to remove himself from being named co-chair of the committee and Pro tem Jebaily seconded the motion.

Mayor Ervin asked the motion maker to consider withdrawing their motion until December. She said there is already the 76 Corridor Study Committee that has been in place since 2018 and already has plans laid out for the 76 gateway.



Pro tem Jebaily called the question and Mayor Ervin continued discussion. She said there are potential economic development funds identified for the east corridor improvements for this corridor and the community should have input.

Council voted unanimously (7-0) in favor of the motion to amend the motion and remove Councilman McCall as co-chair of the East Florence Gateway Study Committee.

Mayor Ervin opened the floor to public comment. Mr. Kermit Moore, President of the East Florence Community Organization, came forward. He said the community would like to have a say in what is done.

Pastor Henry Badie also came forward and suggested this be pushed back to next month to allow the new Councilmembers to begin and give opportunity to speak with and update the community with what is going on. The east Florence community should have a say in what is happening in east Florence.

Mayor Ervin stated it would be best to wait until next month when appointments are being made to committees. If a chair is approved today, who would also be a committee member, the appointment would have to reconsidered again in December once the new Councilmembers are on board. She expressed concern with the attempt to push this through before the new members begin their terms. Mayor Ervin requested that this item be placed on the agenda again next month for consideration. The new members of Council should have the opportunity to be voted upon as chair of the committee.

Pro tem Jebaily called the question and Mayor Ervin continued discussion. She said this ad hoc committee does not need to be placed under another committee. The committee should report to the whole of Council. There is no need to rush the establishment of this committee today, it can be done at next month's meeting. Pro tem Jebaily called the question again.

Mayor Ervin said the question has been called but other members have requested to speak. She asked Mr. Peterson to clarify parliamentary procedure. Mr. Peterson said once the question has been called, the chair then calls for a vote on the pending motion and the pending motion has been amended. Mr. Peterson clarified that a call for the question terminates discussion from members that have already spoken, but still allows for discussion from members that haven't had the opportunity to speak. Having not had the opportunity to speak, Councilman Braddock made a motion to amend the current motion, as amended, to appoint Mr. Kermit Moore as co-chair of the East Florence Gateway Study Committee and Pro tem Jebaily seconded the motion. Council voted unanimously (7-0) on the motion to amend the current motion, as amended, to name Mr. Kermit Moore as the co-chair of the committee.

Council voted 5-2 on the motion, as amended, to approve the formation of the ad hoc East Florence Gateway Study Committee to operate under the Business Development Committee with Pro tem Jebaily serving as its chair and Mr. Kermit Moore serving as its co-chair, whose purpose will be to study the east Florence corridor and provide ideas and recommendations for the redevelopment of that corridor. Voting against the motion were Councilwoman Moore and Mayor Ervin.

#### Community Development Committee, Chaired by Councilwoman Barnes

Councilwoman Barnes said there is nothing to report at this time.

## Marketing and Public Relations Committee, Chaired by Councilman Braddock



Councilman Braddock reported the committee received a report on an annexation and marketing strategy at the last meeting. Current growth and trajectories indicate the city will get the goal of 50,000 residents. The committee also decided not to pursue the All-America City designation at this time as their theme for this year was not a good fit for the city. Councilman Braddock said the November committee meeting will be deferred until new Councilmembers are on board.

### Finance, Audit and Budget Committee, Chaired by Councilman McCall

Councilman McCall said the committee reviewed the monthly financial report and had discussion regarding the opioid settlement. They also reviewed the Accommodations Tax Committee's recommendations that Council voted on earlier in this meeting.

## EXECUTIVE SESSION

Mayor Ervin said Council will be entering into Executive Session to receive legal advice regarding an annexation request, for a discussion of a proposed Economic Development Project and to receive legal advice related to an intergovernmental agreement, to receive an update on legal matters, and a personnel matter.

Without objection, Council entered into Executive Session at 2:20 p.m.

Council resumed open session at 3:23 p.m. and took action on the following items:

#### Bill No. 2022-35 - First Reading

An Ordinance to annex and zone RG-3 approximately 325 acres identified as Florence County Tax Map Numbers 00072-01-007, 00072-01-020, 00072-01-022, 00072-01-024, 00072-01-025, 00072-01-026, 00072-01-026, 169-00-01-027, and 169-00-01-029.

Pro tem Jebaily made a motion to pass Bill No. 2022-35 on first reading and Councilman Braddock seconded the motion.

Mr. Clint Moore, Assistant City Manager of Development, reported this annexation includes approximately 245 acres in Florence County and 57 acres in Darlington County. The proposed zoning of these parcels is RG-3 with approximately 6,000 square foot lots. Once developed, these properties will receive all city services, to include fire, police and sanitation; however, EMS service, tax collection and voter registration will be addressed later as the property develops.

Councilman McCall inquired on the proposed phases of development. Mr. Moore said this development will be approximately 800-900 homes built out over 14 phases.

Council voted unanimously (7-0) in favor of the motion. Bill No. 2022-35 was passed on first reading.

#### Resolution No. 2022-35

Councilwoman Moore made a motion to approve Resolution No. 2022-35 as discussed in Executive Session and Councilman Schofield seconded the motion.

Council voted unanimously (7-0) in favor of the motion. Resolution No. 2022-35 was adopted.

Note 1: Including carryover funds from FY 2021-22, it is anticipated that the amount available for distribution to the requesting agencies of "65% funds" will be approximately \$800,000. The "30% funds" for tourism promotion is estimated to be approximately \$300,000.00.

Note 2: The "30% funds" appropriation to the Florence Convention & Visitors Bureau includes \$15,000 designated specifically to the Florence Center for tourism marketing and promotion expenses, and an additional \$9,000 for a Business Development Fund to help promote the Florence Center for educational, religious, and other conferences.





#### I. ISSUE UNDER CONSIDERATION:

An Ordinance adopting a redistricting plan for the three single member districts of City of Florence, South Carolina in accordance with the Federal Decennial Census of 2020.

- II. CURRENT STATUS/PREVIOUS ACTION TAKEN:
  - 1. At the Council meeting on January 10, 2022, Council voted to defer consideration of redistricting until the first meeting of City Council following the 2022 General Election to avoid rushing through the process and causing confusion regarding the districts since the 2022 Election Calendar would have required completion of the redistricting process by no later than March 1, 2022, approximately two weeks prior to the opening of the filing period for candidates.
  - 2. The City of Florence, since 1977, has been governed by a City Council composed of seven members, one of whom is the mayor, with the mayor and three council members elected at large, and three council members elected from single member districts.
  - 3. The most recent change to the district lines occurred by the passage of Ordinance No. 2014-06 in order to realign the districts in accordance with the data from the 2010 Census.
  - 4. The U.S. Constitution, the South Carolina Code of Laws, §2-20 of the Florence Code of Ordinances, and the Voting Rights Act of 1965 all require that the city make sure that its three districts continue to comply with the Voting Rights Act of 1965 upon receipt and study of the new census data.
  - 5. The data from the 2020 Census indicates that the growth trends in the three districts since the 2010 Census have not resulted in population deviation between the districts that exceeds the standards allowed. The districts remain in compliance with all standards, the boundaries of the districts require adjustment.
  - 6. City Staff has analyzed the Census data, discussed the data with all council members individually, and, with the help of the South Carolina Revenue and Fiscal Affairs Office, has developed several plans for review with council and the public. Numerous neighborhood meetings will be held throughout each of the districts in order to discuss plans and receive public input prior to second reading.

VIII. a. Bill No. 2022-01 First Reading

- 7. Based upon input from council members and the public, the redistricting plan set forth in this ordinance was submitted to Council for first reading on January 10, 2022 for council to choose which of three (3) options it desires to approve on first reading. The first option is the Benchmark, which makes no changes to the present district lines. The other two (2) options do propose some changes to the district lines. The option chosen, plus the other two options, will be presented and discussed during the scheduled public hearings. Each of the three 3 options have population deviation among the districts in full compliance.
- 8. Notice will be given for three public neighborhood meetings, one in each district, and notice will be given that, prior to second reading, Council will hold a Public Hearing prior to second reading in order to receive any additional input or comments from the public on the proposed plan.

# III. POINTS TO CONSIDER:

- 1. This Ordinance will either leave the district lines as they are presently (Benchmark Plan) or adopt changes to the boundaries of the districts. Each of the three (3) options have population deviation among the districts in full compliance.
- 2. At the Council meeting on January 10, 2022, Council voted to defer consideration of redistricting until the first meeting of City Council following the 2022 General Election to avoid rushing through the process and causing confusion regarding the districts since the 2022 Election Calendar would have required completion of the redistricting process by no later than March 1, 2022, approximately two weeks prior to the opening of the filing period for candidates.
- 3. Since the next general election impacting districts is not scheduled until 2026, there is now time to complete the process well before that election.

#### IV. OPTIONS:

City Council may (1) adopt the Ordinance choosing one of the three (3) options on first reading as presented based on information submitted; (2) amend the Ordinance and accomplish first reading; (3) defer action should additional information be needed; or (4) suggest other alternatives.

#### V. RECOMMENDATION:

City Manager and City Attorney recommend adoption of the Ordinance.

# **ORDINANCE NO. 2022-**

# AN ORDINANCE ADOPTING A REDISTRICTING PLAN FOR THE THREE SINGLE MEMBER DISTRICTS OF CITY OF FLORENCE, SOUTH CAROLINA IN ACCORDANCE WITH THE FEDERAL DECENNIAL CENSUS OF 2020.

WHEREAS, in compliance with the United States Constitution, the South Carolina Code of Laws, 1976, as amended, §2-20 of the Code of Ordinances of the City of Florence, South Carolina, and the United States Voting Rights Act of 1965, as amended, the City Council of Florence, South Carolina, has determined to realign the three (3) electoral districts for the election of three (3) members of City Council in accordance with the Federal Decennial Census of 2020;

WHEREAS, there presently exists three (3) single-member districts for the election of City Council members for Florence, South Carolina;

WHEREAS, this Ordinance is for the purpose of re-defining the boundaries of the three (3) single-member districts based upon the 2020 census data in order that the population of such districts shall comply with the requirements set forth in the Voting Rights Act of 1965;

**NOW, THEREFORE**, be it ordained by the City Council of the City of Florence, in meeting duly assembled and by the authority thereof, as follows:

1. The pertinent demographic data in reference to the proposed districts is attached to this Ordinance as Exhibit "A" and is incorporated herein by reference as if fully set forth herein verbatim.

2. The three (3) single-member election districts for the election of City Council members for Florence, South Carolina, are hereby redistricted to be as depicted on the map of the City of Florence which is attached to this Ordinance as Exhibit "A" and incorporated herein by

reference as if fully set forth herein verbatim.

3. The City Manager is hereby authorized and directed to take such administrative actions as might be necessary to promulgate and execute such procedures and policies as may be necessary or desirable to carry into effect and implement the redistricted single-member election districts provided for in this Ordinance in accordance with any directions, suggestions, or objections from the Civil Rights Division, U. S. Department of Justice, after submittal of this Ordinance to the Department of Justice.

4. That this Ordinance shall become effective immediately upon its approval and adoption by the City Council of the City of Florence.







i. Certificate of Appropriateness, provided the Director, acting as the Downtown Planning Coordinator, determines that the materials, paint color, design, architectural features, or style of the project or signage conforms to the application design district in the following situations:

Any project or signage for which the total cost does not exceed \$5,000 \$15,000 in which a specific determination is made by the Director, acting as the Downtown Planning Coordinator, that the subject project is not a part of a larger project.

Attachment 3: Amendments to the Design Guidelines for Downtown Florence, South Carolina Deletions are struck through and highlighted; additions are in red.

#### 1. Chapter 1: Design Principles for Successful Downtowns:

#### **Under "Architectural Design Principles":**

7. Articulate the ground floor of buildings to respond to the pedestrian. Require ground floor architecture in commercial and retail areas to be "open" to the street. The traditional "storefront" in retail areas increases activity and adds to civic life through the display of goods and services. Even where the activities are not strictly retail, such as the ground floor of a restaurant or office, transparency can still be employed to provide enhanced entry areas or views to attractive lobby spaces, atriums, or displays. Where large buildings with few windows must face the street, such areas can be used to create outdoor seating areas or gardens. Consideration of safety must be taken into account, but-whenever possible the use of open security grates or grilles or special thick glass rather than roll down solid metal shutters is recommended in order to make the street attractive even when stores are closed. in order to avoid the implication of blight, roll-down solid or mesh window and door covers are not allowed in the overlay districts. Instead, it is recommended that thicker security glass be installed at the ground level combined with alarm systems if needed. Lighting of the display windows in the evening hours also serves to deter crime. Interior security measures in windows and doors do not require Board review. Decorative Metal security grilles finished in dark colors- are allowed on windows to the side and rear of buildings in this district. may be permitted with Board approval on rear windows and doors only.

#### 2. Chapter 2: D-1 Design Guidelines and Requirements:

#### **Certificate of Appropriateness: Application Fee**

Upon presentation of a signed application, the owner/agent must pay any required fees as determined and approved by the Florence City Council. Once received by the City of Florence the application fee is not refundable. An application fee is not required of any local, state, or federal governmental body. Also, an application fee is not required of any owner or developer for a project which is submitted to the Downtown Planning Coordinator for administrative approval and does not exceed \$5,000, \$15,000 in cost.

The standard application fee for the Design Review Board is \$100 prior to the work being done. If the work has already been started or completed without a Certificate of Appropriateness, the project must be

reviewed by the Design Review Board and the application fee is \$200. Any completed work not approved by the Board will be subject to removal, replacement, or correction to meet the intent of the *Design Guidelines for Downtown Florence, South Carolina*.

#### Certificate of Appropriateness: Approval by the City Planner

For any project or signage which does not exceed \$5,000, \$15,000 the Downtown Planning Coordinator has the authority to administratively approve a Certificate of Appropriateness if it is determined that materials, paint color, design, architectural feature, or style conforms to the applicable District and is not considered to be part of a larger project.

#### 3. Add the following paragraph to each of the indicated chapters and amend in Chapter 3:

- 2: Redevelopment District (D-1) Design Guidelines & Requirements
- 3: Florence Historic District (H-1) Design Guidelines
- 4: Downtown Central District (D-2) Design Guidelines
- 5: Arts and Cultural District (D-3) Design Guidelines
- 6: Timrod Park Residential District (D-4) Design Guidelines
- 7: Food, Artisan, and Warehouse District (W-1) Design Guidelines
- 8: Irby Street Corridor Overlay District (IS-COD) Design Guidelines

#### **Storefront Security**

In order to avoid the implication of blight, roll-down solid or mesh window and door covers are not allowed in the Florence Historic District overlay districts. Instead, it is recommended that thicker security glass be installed at the ground level combined with alarm systems if needed. Lighting of the display windows in the evening hours also serves to deter crime. Interior security measures in windows and doors do not require Board review. 





#### I. ISSUE UNDER CONSIDERATION

For City Council consideration is a resolution establishing a multi-year budget to designate and authorize the use of E-911 funds for Fiscal Years beginning July 1, 2022 and ending June 30, 2029.

#### **II. CURRENT STATUS/PREVIOUS ACTION TAKEN**

On May 12, 1997 City Council approved an ordinance to provide funding for the Enhanced 911 system as authorized by state law in the amount of \$0.77 for each local exchange access in the area served by the City of Florence. E-911 fees collected have since been used to fund the five-year lease-purchase acquisition of 800 MHz radio equipment for the Police and Fire departments, for the acquisition of additional 800 MHz radio equipment, and as a multi-year reimbursement to Florence County for a proportionate share of the construction of a communications tower to serve northern Florence County, including a significant section of the City of Florence.

#### **III. POINTS TO CONSIDER**

A. To maintain the City's current addressing system, which is a vital component of the E-911 response system, these E-911 funds need to be used to fund the City's annual software fees for the addressing system and to offset a portion of the personnel costs for GIS/Addressing positions.

B. These expenditures, identified in **Attachment 1**, are recommended to be funded over a period of seven fiscal years at an approximate cost of \$100,000 per year for a total cost estimated at \$700,000.

#### **IV. STAFF RECOMMENDATION**

Adopt the attached resolution which authorizes the appropriation and continued use of the current E-911 fee as established by ordinance in 1997 for the funding of software and personnel expenditures necessary to maintain the City's current addressing system in the approximate amount of \$700,000, over a period of seven fiscal years.

#### A RESOLUTION TO DESIGNATE AND AUTHORIZE THE USE OF E-911 FEES COLLECTED BY THE CITY OF FLORENCE EFFECTIVE JULY 1, 2022 THROUGH JUNE 30, 2029

WHEREAS, the City of Florence Code of Ordinances, as amended by Ordinance No. 97-12 in May 1997, provides funding for the Enhanced 911 system pursuant to § 23-47-40 (A) of the South Carolina Code of Laws, as amended, in the amount of \$0.77 for each local exchange access in the area served by the City, and

WHEREAS, the City of Florence Code of Ordinances, as amended, further provides that the E-911 service fee shall include charges as may be required by the service supplied and agreed upon by the City and such charges for support, planning, operation and current or future enhancements as required by the City and outlined in SC Code Sections 23-47-10 through 23-47-80, and

**WHEREAS**, since 1997 these fees have been used to fund five-year financing for the lease-purchase acquisition of 800 MHz radio equipment for the Police and Fire departments; to fund a multi-year reimbursement to Florence County for a proportionate share of the construction of a communications tower to serve a significant portion of the City of Florence; and to fund the multi-year acquisition of other emergency communications equipment to include portable and mobile radios, and mobile data terminals, and

WHEREAS, the City of Florence must maintain its current addressing system, which is a vital component of the E-911 response system, which may be acquired pursuant to § 23-47-40 (B) of the South Carolina Code of Laws, as amended, and funded with E-911 fees adopted by the City in Ordinance No. 97-12

#### NOW, THEREFORE, BASED UPON THE FINDINGS OF FACT REFERENCED AND SET OUT ABOVE, IT IS HEREBY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FLORENCE, SOUTH CAROLINA AS FOLLOWS:

a. Effective July 1, 2022, E-911 fees collected by the City of Florence shall be used to fund a total of approximately \$700,000 for the funding of software and personnel expenditures necessary to maintain the City's current addressing system in compliance with § 23-47-40 (B) of the South Carolina Code of Laws, as amended. Said funding shall be appropriated and allocated over a seven-year period, from fiscal year beginning July 1, 2022 through fiscal year ending June 30, 2029, as provided in Attachment 1, which by reference, shall become a permanent part of this resolution.
